Yeah, perhaps when I was . . . When I was a paro, I

CW-1:

And you are already a homeboy?

MARTINEZ:

The deal is that soon I'll be one, but I don't know

when the fuck they are giving me my homeboy

validation.

CW-1:

Well, based on the little stunt you just pulled, it

should be a piece of cake. Ask them once and for all,

dude . . .

MARTINEZ:

[UI]

CW-1:

Listen, I'm going to tell you in good faith, I'm a homeboy, and you know what I mean? I am from the Maras there, and I'm going to tell you, validation my foot! No way, dude. You know that when you hit the mark

like you did with that one, dude.

MARTINEZ:

You know it!

CW-1:

And hey, you just did not take down just any uh,

shithead, any idiot.

MARTINEZ:

No, sir. Big rival gang member!

CW-1:

A huge rival gang member. I had already cracked his

head open, dude. Didn't they tell you . . .

MARTINEZ: Yes, man. The guy couldn't stand to see me.

CW-1: He couldn't stand to see you?

MARTINEZ: He couldn't stand to see me because he would run away

from me.

CW-1: Because he knew that the beast would take him out,

the son of a bitch.

MARTINEZ: So the issue is that I had beaten that asshole already

several times and he had never, he had never been able

to stop me, dude.

CW-1: No fucking way!

MARTINEZ: He could never stop me, the asshole. And wherever

he saw me, he was scared shitless and ran away.

CW-1: Scooby and I, Snoopy and I, ask Snoopy, I gave him

MARTINEZ:

I was leaving and screaming because he was already down. I was leaving and screaming thinking that the dude was dead, man. And the guy stood right up . . .

CW-1:

No fucking way! And what did he say?

MARTINEZ: He told me: "You'll pay for this." He said to me. But

he did not have time to say who the one that broke

him was, dude, because he died.

CW-1: What the fuck? Didn't you go back to stab him more?

MARTINEZ: Uh-huh. But the problem is that there were some women

approaching, doggy. And you know that would have

been a problem.

CW-1: So, the damned guy got right up and he, he, after

you stabbed him, the son of a bitch stood up again?

MARTINEZ: That as shole was going, he ran a short distance and

he fell down, and he fell down, right? So, I caught up to him again and that's when I finished him off,

the time I . . .

CW-1: Oh.

CW-1: He stood up to wait for you?
