1. On Wednesday July 18, 2018 the Special Operations Unit was called in to the Barnstable County Correctional Facility. The call in was associated to a suicide attempt in POD-A. The inmate associated to the attempt was identified as Inmate Sean WALLACE MSA# 0686501. The following is a brief overview of events.
2. At approximately 1640 WALLACE was reported to have [REDACTED] in POD-A. WALLACE subsequently [REDACTED]. This [REDACTED] appeared to cause significant injury to WALLACE. Medical and responding staff reported to POD-A and evaluated WALLACE. WALLACE was subsequently taken out of the facility by Bourne Rescue and transported to Rhode Island Trauma Center located in Providence Rhode Island, ultimately being transported by Med Flight.
3. BCI was escorted to POD-A where the scene was processed. Items identified as belonging to the inmate were secured and inventoried. An investigative file was created with all video footage, event logs, and available pertinent information related to the inmate and the event. Phone calls were also reviewed to determine if there was any motivation or identifying statements leading to the event. Nothing specific was identified indicating the suicide attempt. No note or messages were located on his person or in the cell.
4. Additional information will be added to the file and forwarded as it presents itself.

 At 4:40 p.m. while checking the top tier I saw Inmate WALLACE, Sean(msa0686501) come out of his cell [REDACTED] I ordered Inmate WALLACE to get down and began to run towards him. Dep. [REDACTED] also began to run towards Inmate WALLACE. Inmate WALLACE [REDACTED] I then alerted Central Control via radio and continued to lock the top tier in with responding officers.

The following report is to serve as an Overview Report to Incident Report(s) # 180718471#180718479, #180718492 and Disciplinary Report# 180718474.

- On July 18, 2018 while I (██████████) was assigned as the Facility Shift Supervisor (Swingshift), the following events took place:
1. At 1640 hrs. I responded from Central Control to A-pod for a "man down" duress signal. Upon my arrival, I noticed inmate WALLACE, Sean lying on the A-pod Dayroom Floor, ██████████. Rescue was then requested and dispatched by ██████████ in Central Control. Nurse ██████████ and Nurse ██████████ responded to A-pod and began applying emergency medical treatment to inmate WALLACE. A-pod was simultaneously being secured by responding officers which included Sgt. ██████████, Dep. ██████████, Dep. ██████████, Dep. ██████████, Dep. ██████████, Dep. ██████████, Dep. ██████████, Dep. ██████████ and myself.
 2. 1641 hrs. ██████████ A-33 placed into restraints and relocated to G-pod for throwing an apple directed at officers, at the A-pod Officer's Station, during a Critical Incident.
 2. A-31 (Inmate WALLACE's cell assignment) taken offline for crime scene processing. Lt. ██████████ contacts Radio Room requesting BCI.
 3. 1654 hrs. Bourne Rescue (Lt. ██████████, EMT ██████████, Medic ██████████) into A-pod and communicated that a "Med Flight" would be requested, because of the severity of inmate WALLACE's injuries. 1712 hrs. Inmate WALLACE out of A-pod with Bourne Rescue. Dep. ██████████ identified as the the Officer that would accompany inmate WALLACE, in the helicopter, to Rhode Island Hospital. Dep. ██████████ identified as the second officer for the Hospital Detail. Travel packet generated. 1658 hrs. Bourne Rescue out of A-pod with inmate WALLACE.
 4. Asst. Supt. ██████████ and ADS ██████████ notified and respond to the Main Facility.
 5. BCI into A-pod at 1725 hrs. (CIO ██████████). A-31 processed by (Special Operations) Dep. ██████████ and CIO ██████████. Chain of Custody begun on an altered razor that was confiscated. BCI out of A-pod at 1735 hrs. A-pod to remain in Lockdown for the evening, per Major ██████████.
 6. 1905 Hrs. Dep. ██████████ contacts Central Control to inform location (Critical Care ER Room# 2A , Rhode Island Hospital).
 7. 2240 hrs. Dep. ██████████ contacts Central Control. New location of inmate WALLACE is 7th Floor Recovery /Room#719. EOR.

On Wednesday, July 18, 2018, I, Deputy [REDACTED] was on duty in A- Pod for my assigned 3:30 shift when the following event occurred.

At 4:40 as the top tier was being served their food tray, I was alerted to inmate WALLACE by Deputy [REDACTED] who was in the unit at the time, as [REDACTED] Deputy [REDACTED] ordered him to get down to which he did not comply. [REDACTED]

I activated my man down button and called central control to inform them that medical was needed. At 4:41 P.M. Deputies [REDACTED] [REDACTED], Sergeant [REDACTED] and Lieutenant [REDACTED] responded to the unit with Nurses [REDACTED] and [REDACTED]

Nurse [REDACTED] informed me that they would need 911 called. I called Central Control to inform them of the request.

At 4:54 Bourne Rescue entered the unit to attend to inmate WALLACE.

At 4:58 Bourne Rescue exited the unit with inmate WALLACE on a stretcher. EOR [REDACTED]
